Ensuring the conditions of study from 11th May 2020

Article 1 Subject of the Decision

(1) In order to prevent the spread of the infection caused by coronavirus, and in accordance with the Resolution of the Government of the Czech Republic of 30th April 2020, No. 491, on the adoption of crisis measures, personal presence of students at the study is possible provided the below-mentioned conditions are met, namely at all premises of CZU (i.e. faculties, IEC and school enterprises, KTV, etc.), until further notice.

Article 2

Conditions for personal presence of students at the study at CZU

- (1) The physical presence of students at the study at CZU is possible provided the condition of the presence of the maximum of 15 students in a group is met; this restriction does not apply to clinical and practical teaching and practice.
- (2) The student may participate in the activities mentioned in this Article provided he or she meets the following conditions:
 - a) is without acute health problems corresponding with a viral infectious disease (e.g. fever, cough, shortness of breath, sudden loss of taste and smell, etc.),
 - b) performs hand disinfection with disinfectants provided by CZU,
 - c) has not been ordered a quarantine measure at that time,
 - d) provides a written affidavit declaring that there have been no symptoms of a viral infectious disease in the previous two weeks. This affidavit is submitted by the student to the respective CZU employee before entering the building. The template of the affidavit is published at the CZU website.
- (3) In order to verify students' knowledge (exams and credits) and to conduct teaching, it is necessary to use distance methods primarily (i.e. electronic testing, e.g. in the Moodle environment, evaluation based on submitted tasks and documents, video meetings, e.g. in the MS Teams environment, etc.).
- (4) Where absolutely necessary and with the maximum permissible number and under the conditions specified in paragraph 2 of this Article, contact forms of study are also permissible. When using this form, it is necessary to:
 - a) maintain a safe distance between individuals (minimum 2 m),



- b) comply with the requirements for the use of protective devices covering the nose and mouth (face masks or respirators),
- c) ensure that individual groups of students do not meet at the same place (i.e. set longer time intervals between individual activities) and ensure individual entry of students into buildings and classrooms and their departure from buildings, entry and exit from CZU buildings is possible only in the presence of the respective CZU employee who organizes the activity,
- d) provide disinfectants at the site of the exam.
- (5) The organizer of these activities (examiner or teacher from the ranks of academic staff) is responsible for compliance with all the above conditions, the student is responsible for compliance with the conditions specified in paragraph 2 of this Article, and the faculty/institute is responsible for providing the means of disinfections.
- (6) It is necessary to keep records of the time of presence of individual persons (students and staff) at each faculty and institute.

Article 3 Final Provisions

- (1) This Decision annuls the Rector's Decision 8/2020.
- (2) This Decision shall enter into force upon its publication and shall take effect on 11th May 2020.
